

**NOTICE OF MAKING OF A PUBLIC PATH DIVERSION ORDER**  
**TOWN AND COUNTRY PLANNING ACT 1990, SECTIONS 257 AND 261**  
**THE METROPOLITAN BOROUGH OF SOLIHULL**  
**(M229 BERKSWELL)**

**TEMPORARY PUBLIC PATH DIVERSION ORDER 2018**

The above order, made on 9<sup>th</sup> February 2018 will temporarily divert until 30<sup>th</sup> November 2021 that part of Public Footpath M229 of unknown width as shown with a solid black line on the plan running from Grid Reference SP 23307 80861 (point C on the map) in a generally south west direction for 698 metres to SP 22663 80663 (point B) where it connects with Public Footpath M217. The new path as shown with a broken black line on the plan will run from a point at Grid Reference SP 23307 80861 (Point C) in a southerly direction for 445 metres to SP 23284 80448 (Point E) and then in a westerly direction for 222 metres to Grid Reference SP 23065 80482 (Point D) where it connects with Public Footpath M218. The width of the new path will be 1.8 metres.

A copy of the order and the order map may be seen free of charge and copies of it may be obtained at Solihull Connect within Solihull Central Library and Arts Complex, Library Square, Touchwood, Solihull from 8.30am to 5.30pm Mondays, 9.00am (10.00am Wednesdays) to 5.30pm Tuesday to Friday and 9.00am to 1.00pm Saturday.

Any representation about or objection to the order may be sent or delivered in writing addressed to the Chief Executive, Legal Services, PO Box 18, Council House, Solihull, West Midlands B91 3QS ref RAE/100604 not later than 28<sup>th</sup> March 2018. Please state the grounds on which it is made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Metropolitan Borough of Solihull may itself confirm the order as an unopposed order. If the order is sent to the Secretary of State for the Environment for confirmation, any representations or objections which have not been withdrawn will be sent with the order.

**TEMPORARY PUBLIC PATH DIVERSION ORDER 2018**

This order is made by Solihull Metropolitan Borough Council (“the authority”) under section 261 of the Town and Country Planning Act 1990 (“the 1990 Act”) because it is satisfied that it is necessary to continue to temporarily stop up the footpath to which this order relates in order to enable development to be carried out in accordance with a planning permissions granted under Part III of the 1990 Act including consents under applications numbered PL/2001/02722, PL/2003/01480 and PL/2003/01876/FULM for the purpose of enabling minerals to be worked by surface working and that the authority is satisfied that the footpath can be restored, after minerals have been worked, to a condition not substantially less convenient to the public

**BY THIS ORDER**

1. The footpath over the land situate at Berkswell and shown by a solid black line on the map contained in this order (“the map”) and described in Part 1 of the Schedule to this order (“the Schedule”) shall be temporarily diverted as provided below.
2. There shall be created by and continue to be maintained by Cemex UK Operations Limited at its sole expense to the reasonable satisfaction of the authority to its normal standards an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and show by a black broken line on the attached map.
3. Where immediately before the date on which the footpath was originally stopped up there was apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
4. The diversion of the footpath shall have effect on the date on which the authority confirm this order and shall continue until 30<sup>th</sup> November 2021 whereupon the line of the original path between points B and C shall have been reinstated by Cemex UK Operations Limited at their sole expense to the reasonable satisfaction of the authority

**Description of site of alternative highway**

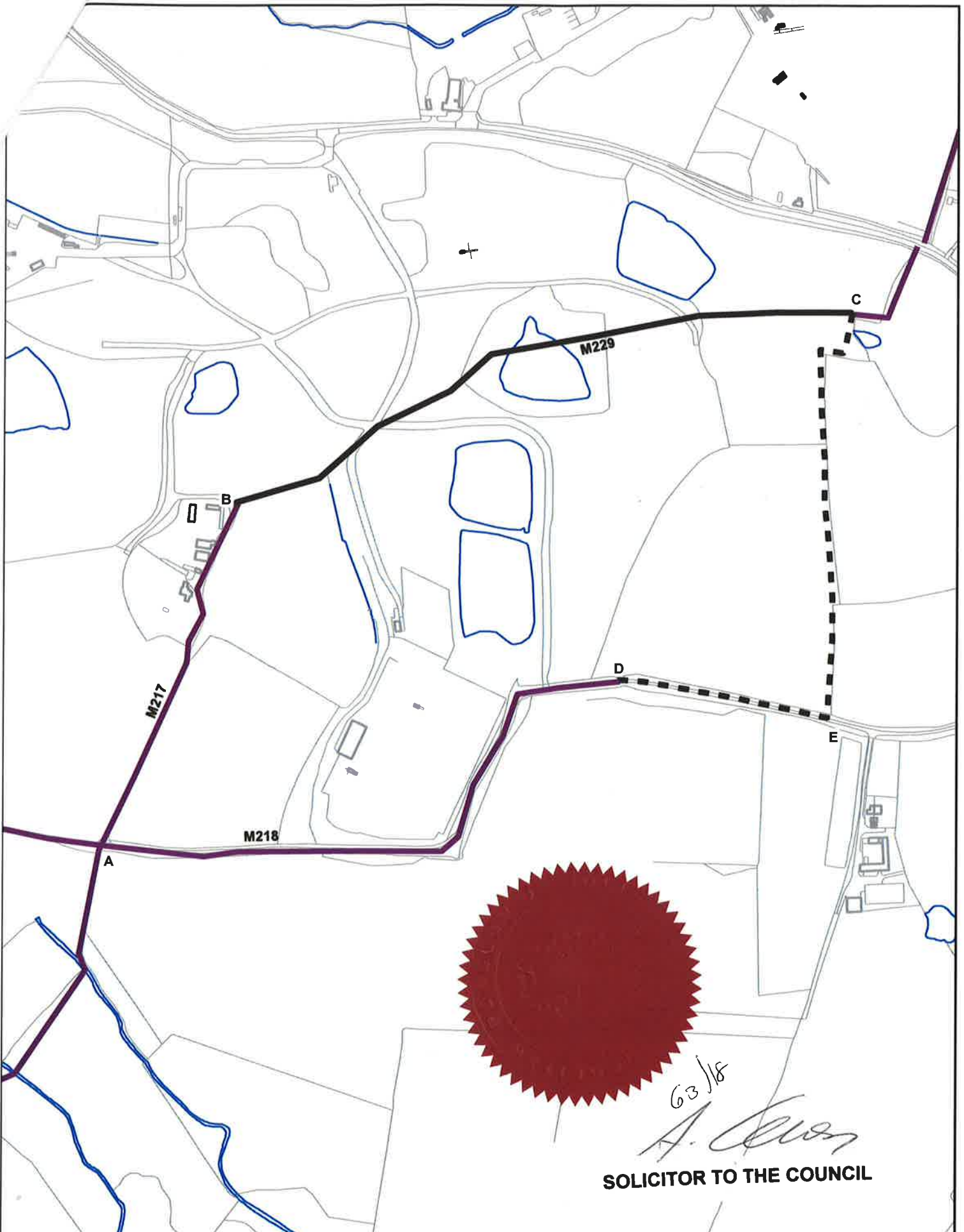
The new path as shown with a broken black line will run from a point at Grid Reference SP 23307 80861 (Point C) in a southerly direction for 445 metres to SP 23284 80448 (Point E) and then in a westerly direction for 222 metres to Grid Reference SP 23065 80482 (Point D) where it connects with Public Footpath M218. The width of the new path will be 1.8 metres.
